# MEDICAL INTERVENTIONS ON CHOPPING BLOCK

After the White House defined sex as only male or female, another executive order aims to curtail "gender" transitions for people under age 19. The order directs federally-run insurance programs, including TRICARE for military families and Medicaid, exclude coverage for such care, and calls on the Department of Justice to vigorously pursue litigation and legislation to oppose the practice. "Across the country today, medical professionals are maiming and sterilizing a growing number of impressionable children under the radical and false claim that adults can change a child's sex through a series of irreversible medical interventions," the order reads. "This dangerous trend will be a stain on our Nation's history,

and it must end." Meanwhile, the Supreme Court agreed to hear Mahmoud v. Taylor, which would determine whether schools can force teachers to read LGBTQ books to elementary-age children despite parental objections. At issue is whether parents will have the right to opt their children out of such instructions.

**SCRIPTURE:** Matthew 18:6; Luke 17:2.

### **BILL PASSED PROTECTING WOMEN & GIRLS**

In mid-January, the U.S. House passed bill HR 28, The Protection of Women and Girls in Sports Act, in a 218 to 206 vote that now heads to the Senate. The bill requires federally funded schools to defend the safety rights of women and girls and would restrict women's sports to those who are born female. The legislation makes it a violation of Title IX rules to allow 'transgender'—those who are born male—to take part in women's athletics in most schools. House Speaker Mike Johnson defended the bill from a Christian standpoint, citing Genesis 1:27: "God created them male and female." "It's biology...[Not] bigotry...[This] is to protect women and girls..." Its passage comes less than a week after a federal district court in Kentucky ruled the administration unlawfully attempted to change the meaning of "sex" in Title IX to include "gender identity." Riley Gaines, collegiate swimmer and women's rights activist, commented, "It is necessary and urgent" to protect girls and women, confirming, "Men do not belong in women's sports."

**SCRIPTURE:** Genesis 5:2; 1 Corinthians, 6:19-20. **PRAY:** The Senate votes to protect women in sports.

# **HOMECOMING & SENATE BLOCKS ICC BILL**

A cease-fire agreement between Israel and Hamas in Gaza took effect Sunday, January 19. Hours later, Israel welcomed home the first three released hostages. Prof. Itai Pessach, head of the hostage recovery team, reassured the public: "I'm happy to report that they are in stable condition. That allows us and them to focus on what is the most important thing for now, is reuniting with their families." Israeli military's chief spokesman Rear Adm. Daniel Hagari stated, "We cannot imagine the horrors these three young women have endured in fifteen months of Hamas captivity. Today we salute and embrace them and their families as they reunite

after so long. [Our] mission is not over until every single hostage comes home." In the U.S., the Senate blocked a bipartisan 243-140 House effort to advance "The Illegitimate Court Counteraction Act" falling six lawmakers short of the 60 needed to bring the legislation to a floor vote. The bill sanctioned the International Criminal Court (ICC) over arrest warrants issued against Prime Minister Benjamin Netanyahu and former defense minister Yoav Gallant. House Foreign Affairs Committee Chairman Rep. Brian Mast had said, "America is passing this law because a kangaroo court is seeking to arrest the prime minister of our great ally, Israel." **SCRIPTURE:** Deuteronomy 32:43; 2 Chronicles 7:20.

### **CHALLENGES FOR CHRISTIANS IN CULTURE**

According to Dr. George Barna of the Cultural Research Center at Arizona Christian University, 2025 will usher in numerous significant changes that will combine to continually redefine the American experience. This, according to a brief report Barna released in late January. Barna emphasized the importance of faith and worldview in shaping a balanced and viable society. "Because a culture is a reflection of people's choices, and those choices are a reflection of people's worldview, and that worldviews are founded on the faith perspectives held by the public, attending to the worldview of the citizenry must be a central focus of family, government, educators, and journalists," he explained. "The coming five years or so represent a prime time for biblical Christians to add direction and value to their culture by strategically and intentionally introducing God's ways and truths into what is presently a turbulent cultural milieu." Barna also noted that Christian parents and churches could play a crucial role in helping the nation get back on track spiritually and morally. "In the end, it's all about worldview."

# **Tonya Nash, Founder**

"If there's any space that should be equipped to welcome autistic people, it should be in places of worship," says Tonya Nash, a wife and mother of two autistic sons. For years, the Nash clan moved as a military family attending different churches. Faithfully attending services became difficult with the unpredictable nature of congregations and crowds, causing anxiety for her sons. Those helping in children's church often didn't know how to effectively work with the boys. In 2013, Bethesda Church of God saw the family's struggle and started a special needs ministry for their oldest son. Bethesda's act of kindness led Tonva to become the founder of Autism Faith Network. The network's mission is to spread autism awareness, acceptance and inclusion in local and faith-based communities worldwide. Four Goals are highlighted: to create awareness about autism; promote the need for timely screenings for autism and early intervention; work to eliminate stigmas about autism; and encourage acceptance and inclusion. The network provides resources, tools and inspiration for autism ministry in local churches.
